To prepare myself for exciting future typographic endeavours, I decided to dust off the old ROTORtype catalogue and release the final versions of our typefaces. The pixels are essentially unchanged, but the metric and kerning tables are updated and the fonts are generated as modern cross-platform OT/TTF files. Great!

Usage

The fonts are designed to be used at 8 points or multiples thereof.

For proper spacing, set kerning to "Metrics".

Letter-spacing should be set to 0 or multiples of 125.

And last but not least; no anti-aliasing!
